We take a lot of time and effort concerning emergency preparedness for adults. However, in an emergency, children are often frightened and confused because they don't know what is going on. Consequently they are the most at risk.

This camp will teach children how to identify an emergency without fear, how to react to it, and how to prevent accidents when possible. They will learn and become certified in CPR and First Aid. They will learn the following: how to stay calm, assess a situation, how and when to make a 911 call, make a fire emergency plan for their home, prepare their own emergency backpack, and what to do in case of smaller household emergencies (loss of power, smell gas, running water, preparing meals alone, etc.). Includes direct training by professionals in the field. Register your child for a life-saving experience!
